#### Structure, governance and management

Members of the PCC are either ex officio, elected by the Annual Parochial Church Meeting, or co-opted in accordance with the Church Representation Rules. All Church attendees are encouraged to register on the Electoral Roll and stand for election to the PCC.

#### Aims and purposes

Emmanuel PCC has the responsibility of cooperating with the priest in charge, Fr Jonathan Kester, in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. It also has maintenance responsibilities for Emmanuel Church.

#### Objects and activities

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community. The PCC maintains an overview of worship throughout the parish and makes suggestions on how our services can involve the many groups that live within our parish. Our services and worship put faith into practice through prayer and scripture, music and sacrament.

When planning our activities for the year, the Incumbent and the PCC have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on charities for the advancement of religion. In particular, we try to enable each and every person to live out their faith as part of our parish community through:

- Worship and prayer; learning about the Gospel and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- · Missionary and outreach work.

To facilitate this work it is important that we maintain the fabric of Emmanuel church.

# **Achievements and performance**

#### Church attendance

For the year ending 2018, there are 269 parishioners on the Church Electoral Roll, some 85 of whom are not resident in the Parish. The average Sunday attendance during the year was 206 adults and children (200 in 2017), but this number increased significantly at festivals. Average attendance at weekday services (on Monday and Wednesday) was 10 and on Thursday during term time the whole school attended mass.

During the year 22 candidates were confirmed (4 adults and 18 children) compared with 17 candidates in 2018 (1 adult and 17 children). There were 19 baptisms (compared with 18 in 2017). There was 1 wedding (compared with 2 in 2017).

## Review of the year

The full PCC met 6 times during the year with an average level of attendance of 80 per cent. Committees met between meetings and minutes of their deliberations were received by the full PCC and discussed where necessary.

We continued to be most grateful to our self-supporting priest, Mothers Annette Fritze-Shanks for all her time, pastoral care and wisdom as well as her sacramental and liturgical input throughout the year. During the year Father Regan O'Callaghan, priest and iconographer, who is resident at the Vicarage continued to serve as Honorary Associate Priest. Their ministry is very much appreciated by all of us.

## Emmanuel Church, West Hampstead Financial Statements for the year ended 31st December 2018

In May 2018, Fr Jonathan was appointed to serve as Area Dean of the whole of Camden, serving all the parishes in the north and the south of the Borough of Camden, liaising and working with community leaders and sub-deans and chairing the Camden Deanery Synod and Chapter.

Fr Jonathan continued as Priest in Charge of St Cuthbert's, West Hampstead assisted by Mother Alysoun Whitton as the priest with Pastoral Responsibility for that Church until May 2018. After a six-month period of interregnum Father Hugh Thomas was licensed to St Cuthbert's on 4 November 2018.

Fr Jonathan also serves as a of Governor at Emmanuel School and as a trustee of the CARIS Camden, the Community Association of West Hampstead and the Fitzdale Trust.

At the APCM 2017, Robert Cox and Harin Perera were elected as Churchwardens. At the first meeting of the PCC immediately after the APCM, Rob Marshall was elected as treasurer and Clare Fuller as PCC Secretary.

#### **Parish Office**

The Parish Office continues to be housed in the upstairs Choir Room. Our Parish Administrator, Nicki Siddall oversees the bookings and administration of the Community Space.

#### **Community Space**

The community facilities at the west end of the Church were frequently in use in 2018 for a whole range of activities from baby music groups, a children's theatre and stage school, for tap dancing, acrobatics and Brazilian Jiu Jitsu, Pilates, Yoga, Meditation, the West Hampstead branch of the Women's Institute, WHAT committee, various residents' meetings, as well as for concerts and the regular rehearsals of the Fortune Green and Cantereas Choirs and a local polling station. We have also been the venue for various activities for the campaign to release local resident Nazanin Zaghari-Ratcliffe from prison in Iran. All this is demonstrating that the new space is fulfilling our vision to serve the whole community of West Hampstead in all its diversity.

#### Winter Night Shelter

For the third season we hosted the C4WS Winter Night Shelter for the homeless from our Borough of Camden on Tuesday nights from November to January. The facilities were well used and much appreciated by all our guests who stayed. We have the best shower and sleeping facilities of any Church who participates in the scheme. We are so grateful to all our volunteers who cooked, made beds, cleaned, to local restaurants and shops who generously donated food and to all who cared for those who stayed with us so well.

#### Children's Work

We continued our central work with children throughout the year, not only at our 9.15 am Joyful Noise Eucharist but in our Sunday School in term during the 10.30 am Sung Eucharist. Many thanks to Claire Hammett who coordinates this work so ably.

#### Work with our older members

In a parish so full of young life it is important that we remember our older and senior members who are much valued members of our parish family. Our monthly Fellowship lunch on the first Wednesday of each month grew in numbers through the year. Many thanks to Diana Malzer who coordinates the catering for and communication with this wonderful group of people.

# Safeguarding

Mother Annette Fritze-Shanks served as Safeguarding Officer throughout the year and Casey Hammett served as Children's Champion. All relevant DBS checks were undertaken.

# Emmanuel Church, West Hampstead Financial Statements for the year ended 31st December 2018

#### **Financial Review**

Our total income for the year was £142,025 (2017: £130,195) and the details are in the financial statements. Donations from parishioners still account for the largest share of our income, contributing £78,222 (2017: £78,997). Our income from investments was stable at £14,244 (2017: £14,204). The year brought continued growth in income from letting our community rooms, to £43,899 (2017: 33,131).

We are required to show our investments at their market value at the end of the year and the gain or loss is reported in our Statement of Financial Activities.

£152,488 (2017: £131,785) was spent to deliver Christian ministry from Emmanuel Church, including a contribution of £75,140 (2017: £72,800) to the diocesan parish share (the Common Fund), which provides the stipends and housing for the clergy, pension and national insurance contributions as well as contributing to the wider life and ministry of the Diocese of London and Church of England.

In 2018 we were pleased to reach our goal of becoming a self-funding parish, making our full contribution to the Common Fund. The increase in our offer has stretched the Parish finances for 2018, but we are striving to maintain a stable financial position through the generous stewardship of our congregation and further letting activity.

# **Reserves policy**

It is PCC policy to maintain a balance of net current assets on unrestricted funds of approximately 4 months' unrestricted payments, to cover emergency situations that may arise from time to time.

#### **Notes to the Financial Statements**

#### 1 ACCOUNTING POLICIES

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland', the Charities Act 2011 and the Charities Act 2011. The financial statements have been prepared under the historical cost convention except for investments which are included at market value, as modified by the revaluation of certain assets

### Financial reporting standard 102 - reduced disclosure exemptions

The charity has taken advantage of the following disclosure exemption in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

the requirements of Section 7 Statement of Cash Flows.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value.

The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law.

#### **Funds**

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted.

The accounts include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body nor those that are informal gatherings of church members.

#### **Incoming Resources**

Voluntary income and capital sources

Collections are recognised when received by or on behalf of the PCC.

Income tax recovered and recoverable under the Gift Aid scheme during the financial year has been accrued.

Grants and legacies to the PCC are accounted for when the PCC has legal entitlement to the funds.

Other ordinary income

Rental income from the letting of church premises is recognised in the period when the rental is due.

Income from investments

Dividends and interest are accounted for when receivable

Gains and losses on investments

Realised gains or losses are recognised when investments are sold. Unrealised gains or losses are accounted for on revaluation of the investments at 31 December.

#### Resources used

Grants

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding obligation on the PCC.

Activities directly relating to the work of the Church

## Emmanuel Church, West Hampstead Financial Statements for the year ended 31st December 2018

The diocesan quota or common fund is accounted for when payable. Any quota unpaid at 31 December is provided for in these accounts as an optional (though not a legal) liability and is shown as a creditor in the balance sheet.

#### **Fixed assets**

Consecrated land and buildings and movable church furnishings

Consecrated and beneficed property is excluded from the accounts by s.10(2) (a) and (c) of the Charities Act 2011

No value is placed on movable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal since the PCC considers this to be inalienable property. All expenditure incurred during the year on consecrated or benefice buildings and movable church furnishings, whether maintenance or improvement, is written-off as expenditure in the Financial Statements and separately disclosed.

Other fixtures, fittings and office equipment

Equipment used within the church premises is depreciated on a straight-line basis over 4 years. Individual items of equipment with a purchase price of £1,500 or less are written-off when the asset is acquired.

#### Investments

Investments are valued at market value at 31 December.

#### Current assets

Amounts owing to the PCC at 31 December in respect of fees, rents or other income are shown as debtors less provision for amounts that may prove uncollectible. Short-term deposits include cash held on deposit either with the CBF Church of England Funds or at the bank.

INDEPENDENT EXAMINER'S REPORT TO THE MEMBERS OF THE PAROCHIAL CHURCH COUNCIL OF EMMANUEL CHURCH, WEST HAMPSTEAD

I report on the accounts for the year ended 31 December 2018 set out herein.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

It is my responsibility to:

#### Basis of the independent examiner's report
